

**Subject:** Information under Right to Information Act, 2005 –Request No.MOPNG/R/2016-50618 dated 23.04.2016.

Madam,

With reference to you RTI Request No. MOPNG/R/2016/50618 dated 23.04.2016, in so far as this Ministry is concerned, it is stated that the points on which the information is sought are interrogatory in nature and not for seeking any information in material form and hence your application is not covered under the word information as defined in Section 2(f) of the RTI Act, 2005.

2. However, based on the information available on record in this Ministry, it is intimated that:-

- (i) As regards point No.1, Ceiling (spending limit) is prescribed as per the extant guidelines vide Ministry of Finance & Department of expenditure vide order No.7(8)E-Coord./94 dated 16 July 2009(copy enclosed) as per following :-

Minister's Office in his residence	Rs.2 lakhs for furniture & furnishings and Rs.1 lakh for electrical appliances.
Minister's Office in the Secretariat	Rs.6.5 lakhs for furniture & furnishings and Rs.1.5 lakhs for electrical and A/C appliances.

- (ii) As regards point No.(ii) (iii) & (iv) of the application it is intimated that based on the requirement, necessary civil and electrical work in the office of Shri Dharmendra Pradhan, Hon'ble Minister of State(Independent Charge), Petroleum & Natural Gas at Shastri Bhawan, New Delhi was done by the office expenses of the Ministry of Petroleum & Natural Gas through CPWD. A copy of the statement showing expenses incurred is enclosed herewith. No renovation work has been undertaken by the Ministry in the residence of the Hon'ble Minister. However, a copy of your application is forwarded to CPWD, who is the concerned authority for renovation work in Government accommodations, for providing the requisite information.


